PURPOSE

In compliance with European General Data Protection Regulation 2016/679, we inform you that Hippie Shop Formentera will process the data you provide us for the following purposes:

- 1) To correctly execute the management of our services, consisting of:

 - 1.3 Management of our services, including reminders, technical notices, updates, security alerts, support messages, among others;
 - 1.4 Registering and managing the resolution of in-store incidents and online incidents.
 - 1.5 Registering and managing the communication channels between the customer and Hippie Shop Formentera, using the "Contact us" application, or by letter, email or telephone, including the recording of your calls, with our customer services.
- 2) To send commercial notifications to inform you of our products and notifications related to Hippie Shop Formentera competitions, and to conduct satisfaction questionnaires, as long as we have your consent to do so. Satisfaction questionnaires are conducted to offer

you personalised service in order to improve your shopping experience at Hippie Shop Formentera.

- 3) Analysis of your behaviour as a user as well as commercial profiling to show personalised advertising adapted to your preferences and, wherever applicable, to your browsing history. Hippie Shop Formentera will produce your commercial profile based on data collected through third-party sources including, for example, third-party cookies. No automated decision-making which may have legal or similarly significant effects on you will be made based on said profiling. Commercial profiling through cookies may be used by third-party websites to show you personalised advertising.
- 4) In addition, Hippie Shop Formentera will produce your commercial profile based on (i) the information you provide; (ii) your own cookies (wherever applicable); (iii) your purchasing history; (iv) how often you open your emails, and (v) your replies to any satisfaction questionnaires we may send you. No automated decision-making which may have legal or similarly significant effects on you will be made based on said profiling. Bear in mind that the analysis of your behaviour as a user allows us to improve your experience as a customer of the Hippie Shop Formentera brand.
- 5) Prevention of abuse and fraud in the use of our services (e.g. fraudulent activities, denial-of-service attacks, spam, among others).
- 6) Transfer of data to public bodies and authorities, whenever required in accordance with legal and statutory provisions.

PERIOD OF DATA CONSERVATION

How long do we keep your data?

Your data will be kept as long as the contractual and commercial relationship remains in force, until you request their elimination, or the time necessary to fulfil legal obligations.

LAWFUL BASIS

What is the lawful basis for processing your data?

The lawful basis for treating your data lies in:

- •The execution of a contract with Hippie Shop Formentera, in relation to section 1.
- •The consent provided by you, in relation to the purposes indicated in sections 2, 3.
- ●The legitimate interest of Hippie Shop Formentera, for the purposes indicated in sections 4 and 5 above.
- ●In relation to section 4 above: Legitimate interest lies in showing you products which we believe may be of interest to you due to their 'similarity' to other products of the brand you have purchased and based on your commercial profiling. To this effect, Hippie Shop Formentera will monitor your behaviour in order to determine whether you would benefit from other Hippie Shop Formentera brand offers or products. Your commercial profile is produced with information belonging to Hippie Shop Formentera.
- •In relation to section 5 above: Legitimate interest lies in protecting Hippie Shop Formentera users through the prevention of abuse and fraud in the use of our services.

•Compliance with the legal obligations applicable to Hippie Shop Formentera, for the purpose indicated in section 6 above.

ADDRESSES

To which addressees will your data be communicated?

Your data may be communicated to third parties in the following cases:

- •€€€€€€Your personal data may be processed by suppliers who provide services to Hippie Shop Formentera, such as services for content storage, instant messaging, sending notifications, advertising services, etc. Hippie Shop Formentera has signed the corresponding data processor agreements with each of the suppliers who provide services to Hippie Shop Formentera in order to ensure that your personal data are treated in accordance with the provisions established in the applicable legislation.
- •€€€€€€€Your personal data may also be transferred in cases where a legal obligation exists.

RIGHTS

What are your rights when you provide us your data and how can you exercise them?

You have the right to obtain confirmation of whether or not Hippie Shop Formentera is processing personal data that concerns you.

You also have the right to access your personal data and to request the rectification of inaccurate data or, wherever applicable, request their erasure when, among other reasons, the data are no longer necessary for the purposes they were collected for.

In certain circumstances, you may request the restriction of the processing of your data, in which case we will only keep them for the exercise or defence of legal claims.

We will use cookies to save your favourite products.

We use both first- and third-party cookies to collect statistics and user data in aggregate and individual form in analysis tools to optimize our site and to present you with relevant marketing material.

Some third-party cookies are set by services that appear on our pages and are not in our control. They are set by social media providers such as Facebook and relate to the ability of users to share content on this site, as indicated by their respective icon.

We also use third-party cookies which performs cross-site tracking in order for us to give you marketing in other sites/channels.

WHAT TYPES OF PERSONAL DATA DO WE PROCESS?

We will only connect your cookie ID to your personal data submitted and gathered in relation to your account if you are logged in to your account Hippie Shop Formentera.

WHO HAS ACCESS TO YOUR PERSONAL DATA?

Data that is forwarded to third parties is only used to provide you with the services mentioned above, analysis tool in order to collect statistics to optimize our site and present you with relevant material.

WHAT IS THE LEGAL GROUND TO PROCESS YOUR PERSONAL DATA?

HOW LONG DO WE SAVE YOUR DATA?
